## 1. Welcome and Apologies:

- **BT phone Box**

- **Local Policing:**

- **Owl Street Survey:**  
Ros advised she had conducted a survey of Owl Street residents regarding the confusion over the name. Most residents preferred Owl Street to Main Street, although the two oldest residents insisted the original name was Main Street. Ursula said she would forward the survey to the Council.
